- I am the Honorary Secretary of Al-Ameen Educational Trust, Edappally, Kochi-24.
  The Al-Ameen Educational Trust is a Charitable Trust, registered under Indian
  Trust Act 1882, on 10/10/1978 with Registration No.386 of 1978 of the Sub
  Registrar Office, Ernakulam having its registered office at Edappally.
- 2. The Al-Ameen Educational Trust, Edappally, started Al-Ameen Public School, Sreemoolanagaram on 16/04/2002 to meet the educational needs of the public in general and economically poor and vulnerable sections of the community in particular. The Trust adopted the syllabus of Central Board of Secondary Education, New Delhi since there is no similar type of educational institutions in the locality.

- 3. The Al-Ameen Public School, Sreemoolanagaram is conducting classes from Class I to Class XII for 702 students at present.
- 4. The Bye Laws of the Central Board of Secondary Education, stipulates that the Trust running the school shall be of non-proprietary in character and an affidavit shall be furnished by the Secretary of the Trust stating how the members of the Trust is related to each other or they are not related to each other duly attested by a First Class Magistrate as per Appendix1(3).
- 5. Al-Ameen Public School, Sreemoolanagaram, Ernakulam District is run by Al-Ameen Educational Trust, Edappally, Kochi-24, which is of a non-proprietary character and its Deed of Trust is such that is does not vest control in a single individual or members of a family and the aim of the Trust is to impart quality education to the children and not to earn profit.
- 6. The Management of the Al-Ameen Public School, Sreemoolanagaram rests with the Board of Trustees of the Al-Ameen Educational Trust whose name, address occupation are given below:
